

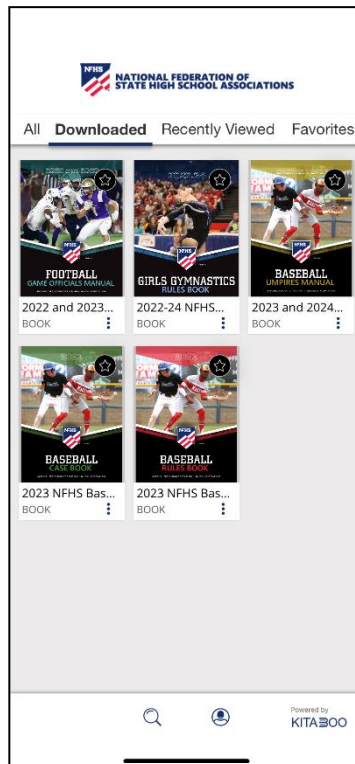

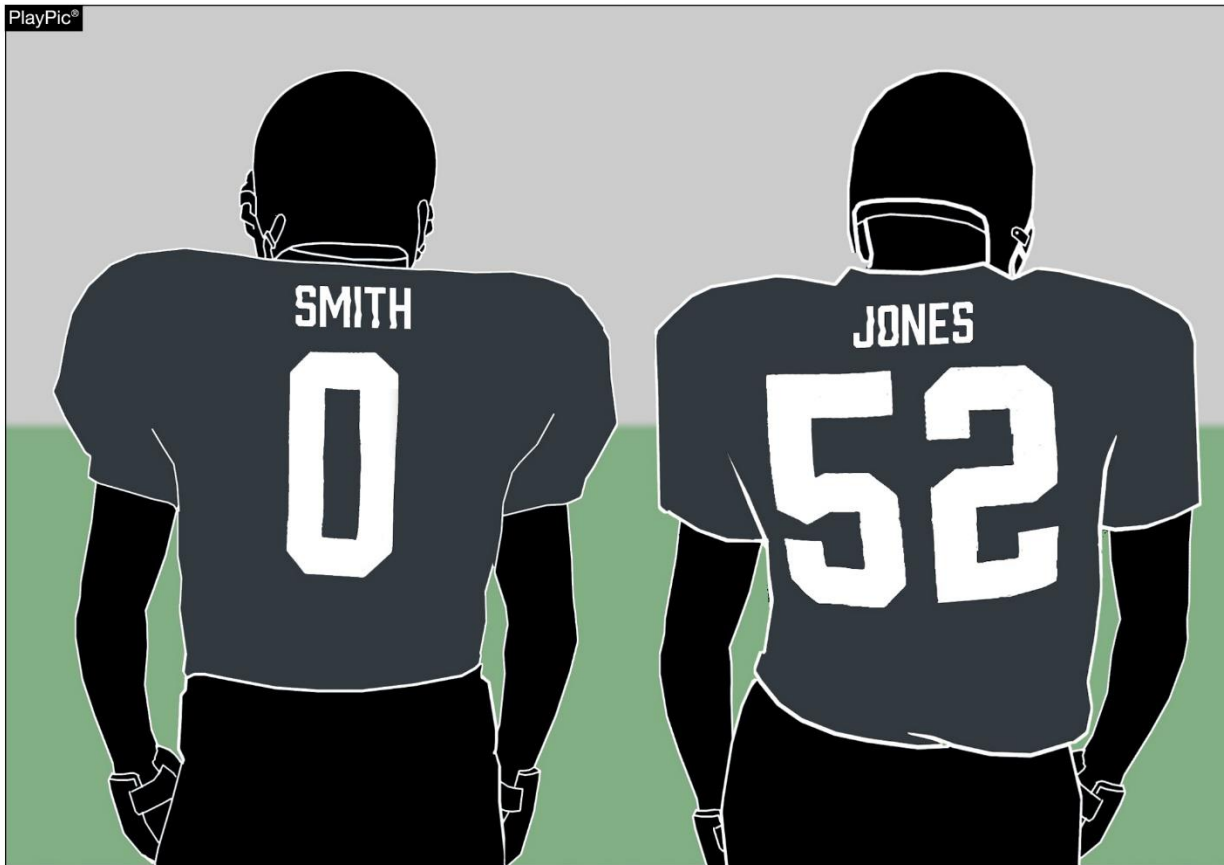
Each state high school association adopting these NFHS football rules is the sole and exclusive source of binding rules interpretations for contests involving its member schools. Any person having questions about the interpretation of NFHS football rules should contact the football rules interpreter designated by the respective state high school association.

The NFHS is the sole and exclusive source of model interpretations of NFHS football rules. State rules interpreters may contact the NFHS for model football rules interpretations. No other model football rules interpretations should be considered.





HOME JERSEYS RULE 1-5-1b(3)

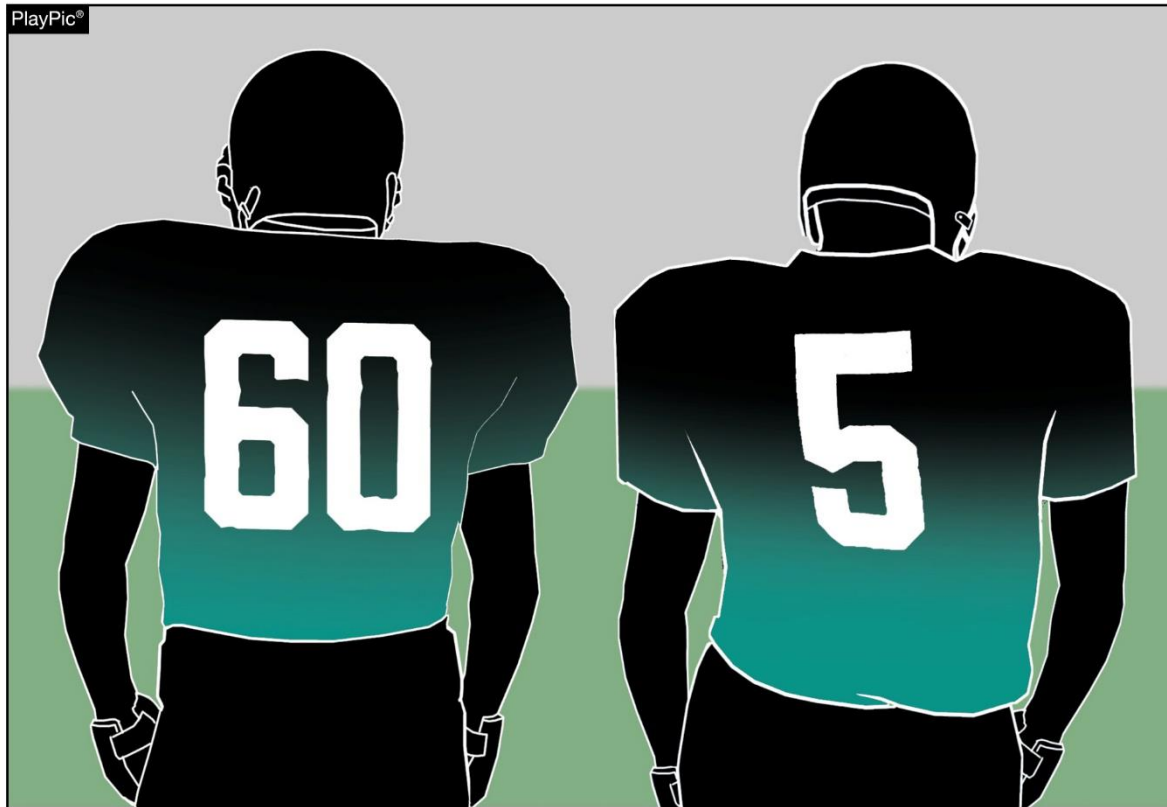


LEGAL

Jerseys of the home team shall all be the same dark color(s) that clearly contrasts to white.

These jerseys are legal because it is the same dark colors. All players on this home team shall wear the same dark colored jerseys in order to comply with the rule.

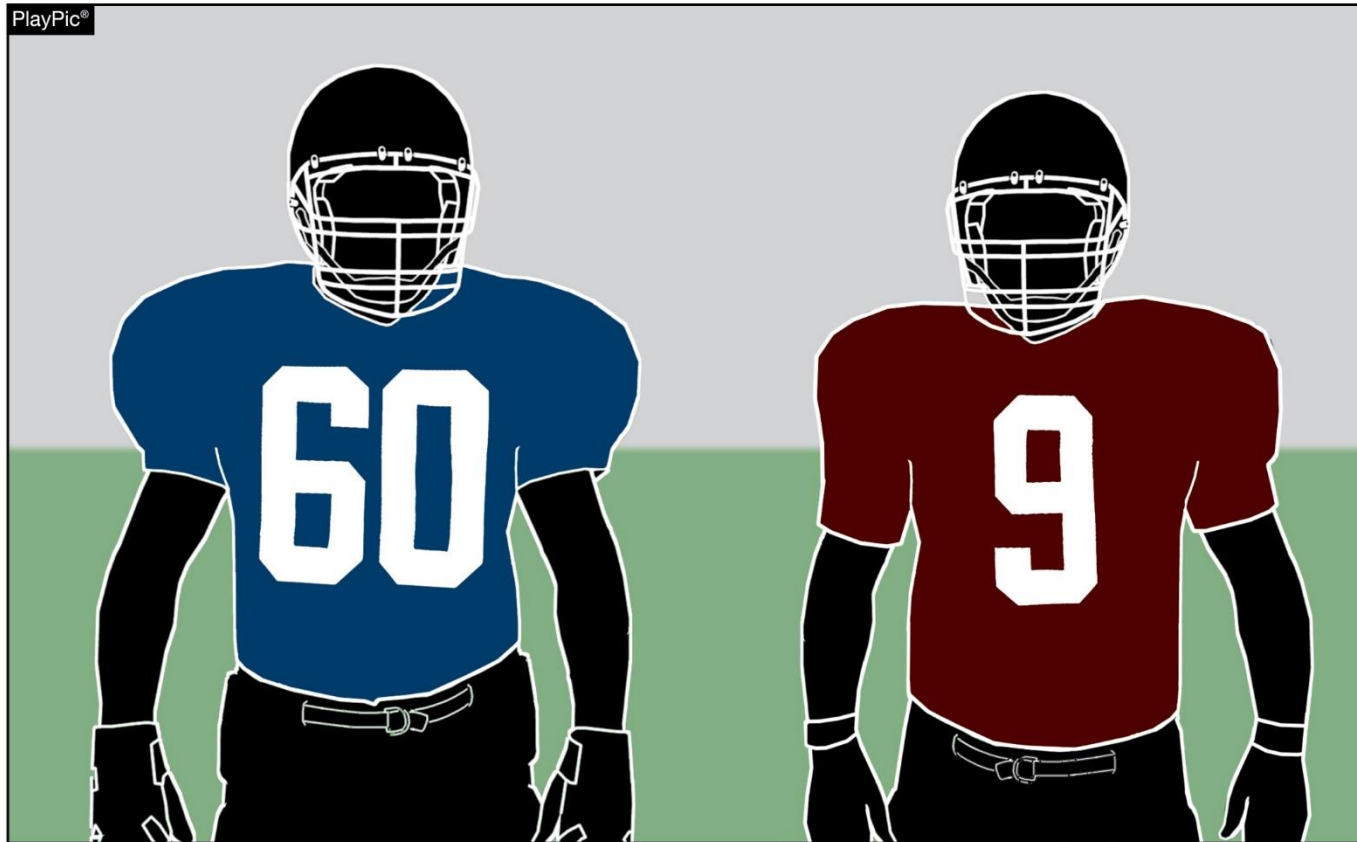

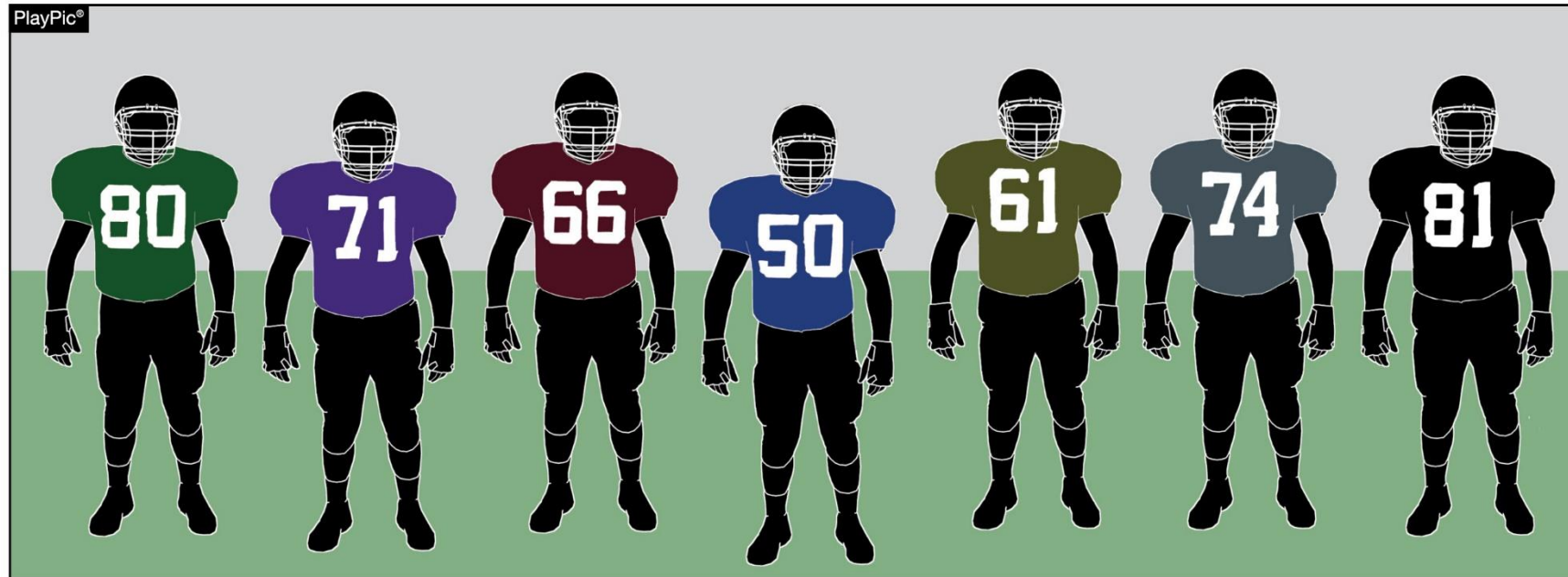


These jerseys of the home team are illegal because all members of the home team must wear the same dark color(s) that clearly contrasts to white.

PIAA ADOPTED

- “Any Coach and/or adult Team Personal removed, ejected or disqualified from a Contest who refuses to leave the competition area (out of sight and sound) as directed by the Contest Official will result in a forfeiture of the Contest.”

This policy has been adopted by the PIAA Board of Directors in an effort to address poor acting adults who refuse to abide by the applicable rules book and to show support of PIAA officials.

Beginning with the 2024 season:

- The Team Box for Players, Coaches and all team personal will revert to having them all be inside the team box between the 25-yard lines.



PIAA ADOPTION FOR 2024 SEASON

- **Enforcement Policy/Procedures- Football Uniform Violations**

The enforcement of uniform rules is a shared responsibility of the coaches, players, and officials and through the work of all groups the safety of players can be enhanced. This includes but is not limited to: Knee pads fully covering the knee, Jerseys tucked in or to the belt line of the pants, Eye black one single solid stroke, two mouth pieces, etc. (1-5-1 through 6).

- **Mechanics:**
- During the pre-game private meeting with the head coach the referee and another crew official will mention that Player Equipment and Enforcement is a Point of Emphasis this year and their help in enforcing and protecting players would be greatly appreciated.
- When viewing warmups, officials need to address any players whose uniforms do not comply with the rules. Officials should note those players' numbers on their game card in the event these same players violate during play. Officials will notify the Head Coach prior to the start of the game. (Officials shall be on the field 30 minutes prior to gametime to observe warmups.)



PIAA ADOPTION FOR 2024 SEASON

- At the coaches/captains meeting, again, player safety must be stressed as it relates to uniform violations and that officials are trying to protect players and keep them from injury and within the NFHS rules.
- When officials notice a violation during play the player needs to be notified of the violation and the player's number recorded on game cards. The player is to be removed for one play and the head coach notified. Player shall not return to the game until the violation has been corrected. This is in accordance with Rules 1-5-5, 1-5-6 and 3-5-10(e).
- When the same player is noticed a second time for same violation, send them off and have a conversation with the head coach about the violation prior notification to the player. Remind the head coach that another violation by the same player will result in a UNS on the head coach. Record this violation on game cards. This is in accordance with Rules 1-5-5, 1-5-6 and 3-5-10(e).





PIAA ADOPTION FOR 2024 SEASON

- If there is another (third) violation on the same player or if the coach is not responsive to the message above, the head coach will be assessed a UNS and 15-yard penalty in accordance with Rule 9-8-1(h). Record this on official's game cards, this is the first UNS charged to the head coach as it relates to disqualification.
- **These are only guidelines/suggestions for officials to use if they see fit. There is nothing that prevents an official from strictly enforcing NFHS Football Rule 9-8-1 as written.**



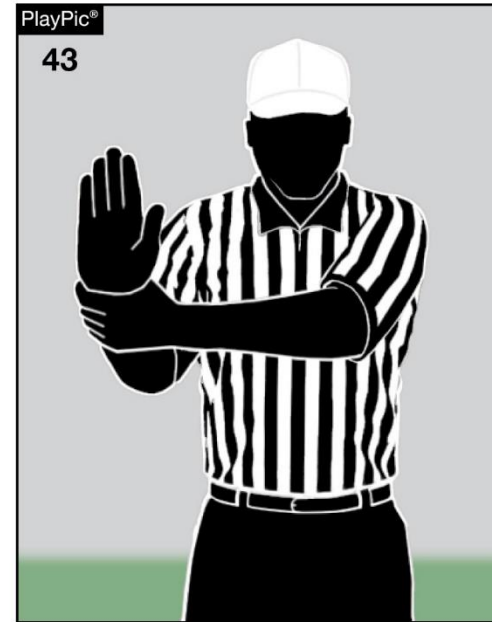
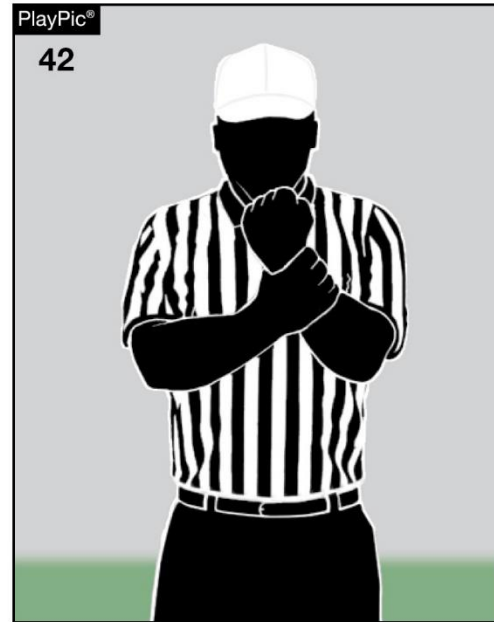

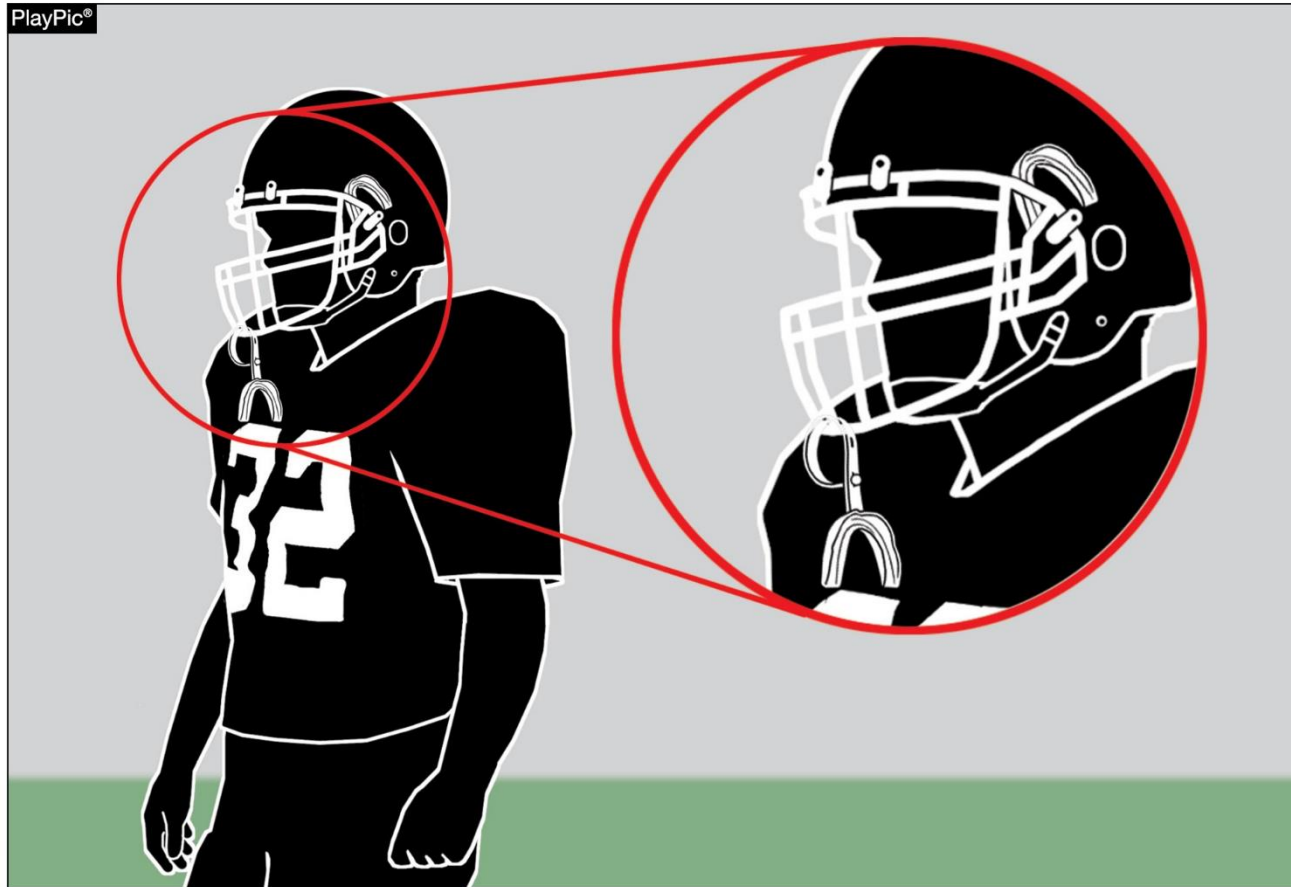
SIGNAL CHART

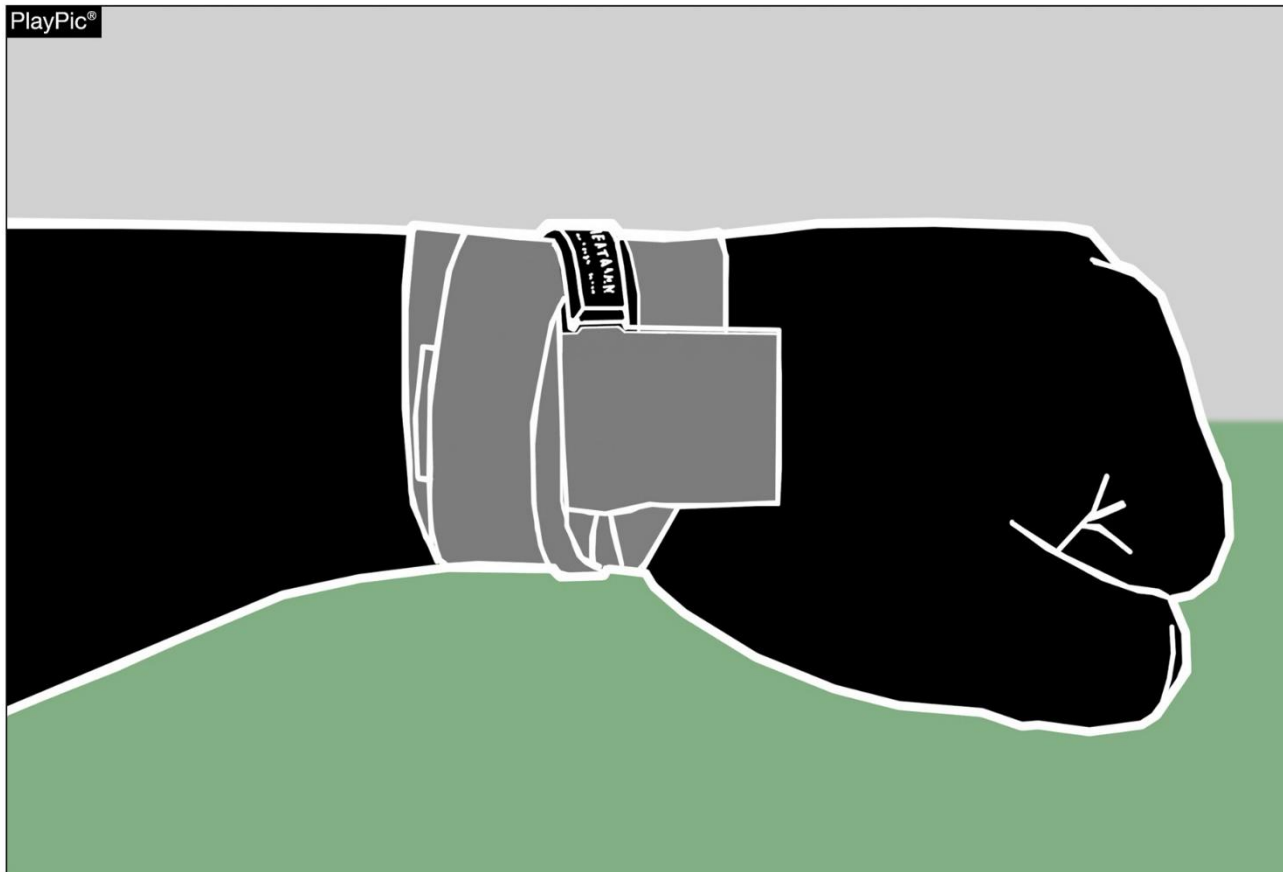


TOOTH AND MOUTH PROTECTOR RULE 1-5-1d(5)a



Players may have only one tooth and mouth protector.

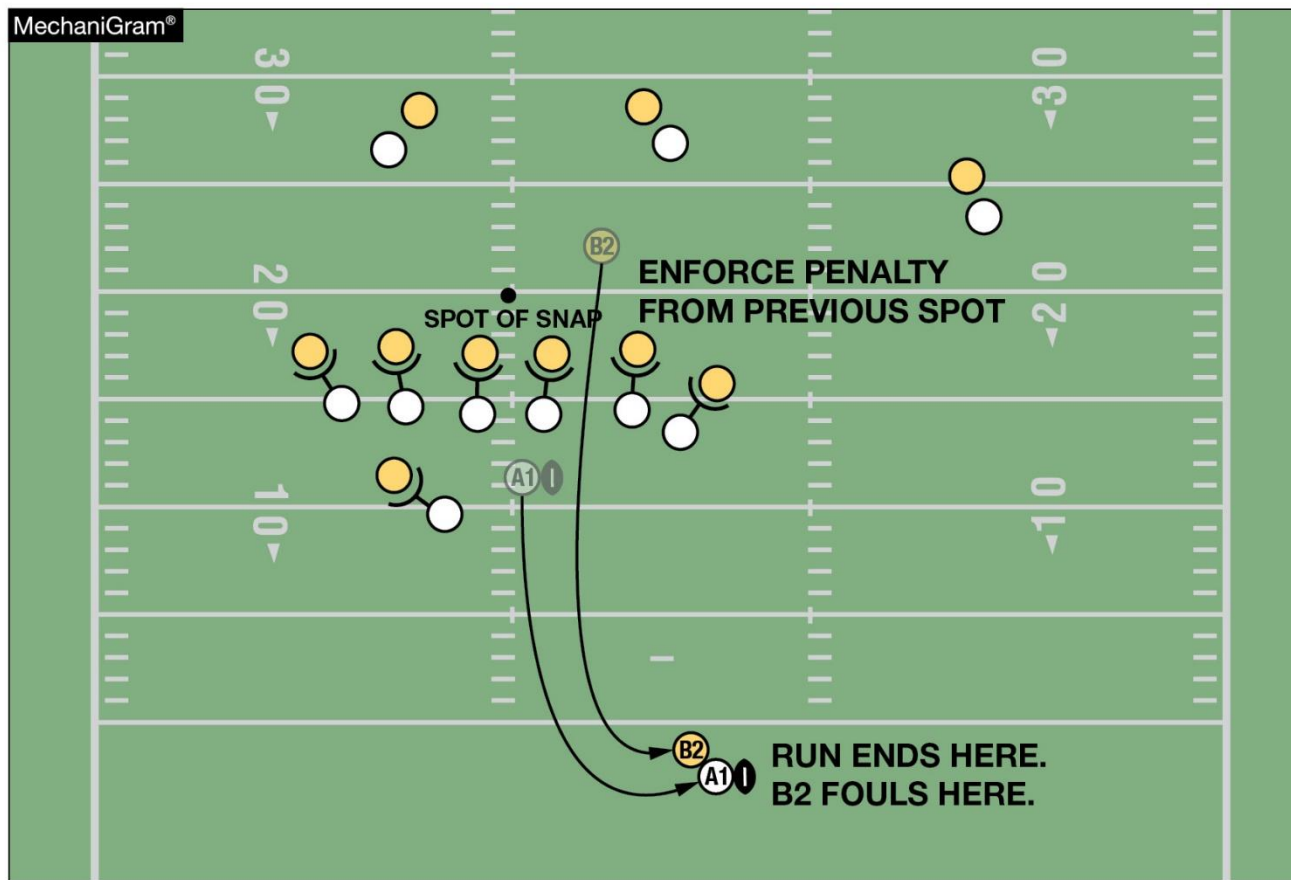
ILLEGAL EQUIPMENT RULE 1-5-3c(6)



Religious medals and a medical alert such as the one shown in the PlayPic are not considered jewelry. Religious medals or other religious items must be taped to the body and worn under the uniform. A medical-alert indicator must be taped to the body and may be visible.



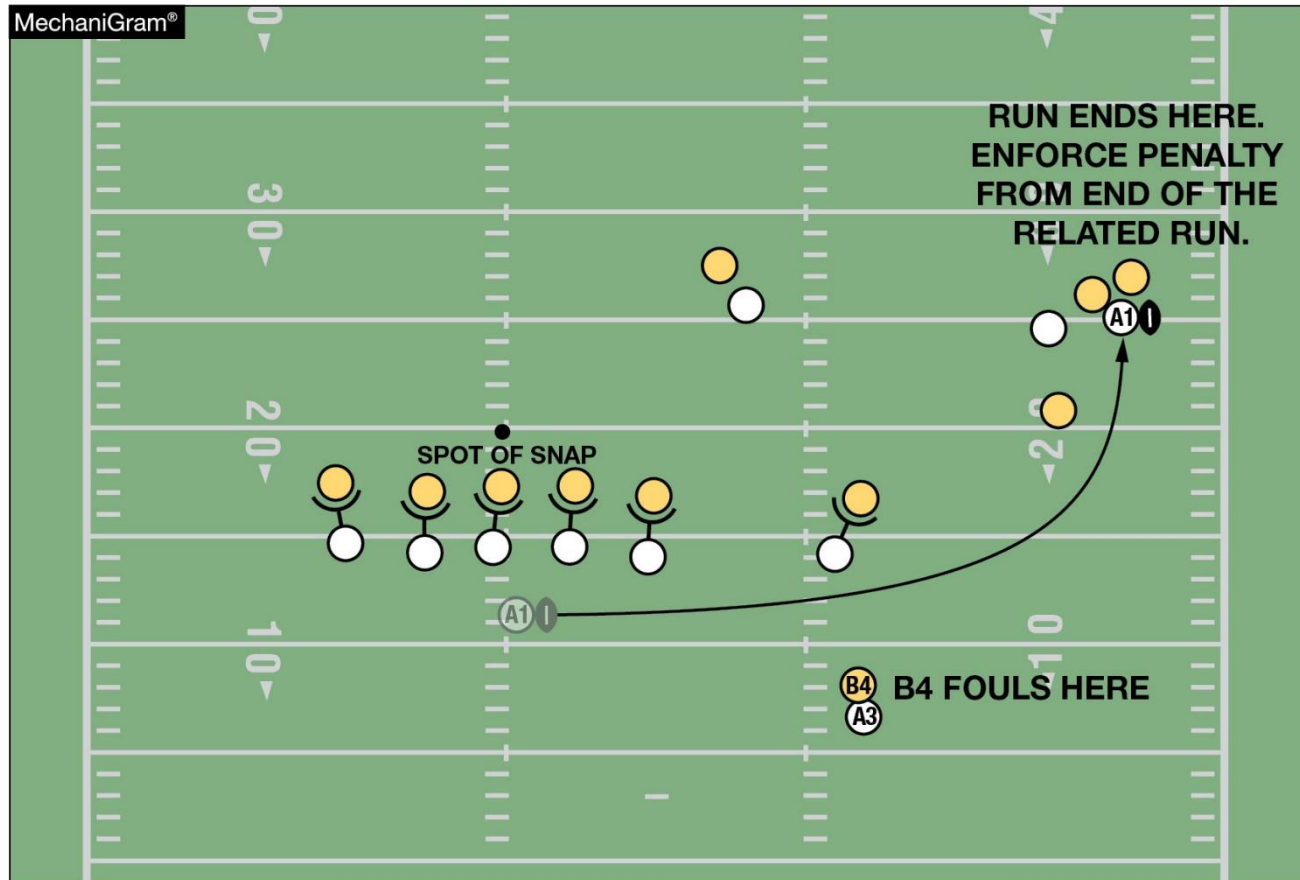
BASIC SPOTS RULE 10-4-2d



The penalty for this foul is enforced from the previous spot. Under the old rule, the penalty would have been enforced from the goal line.



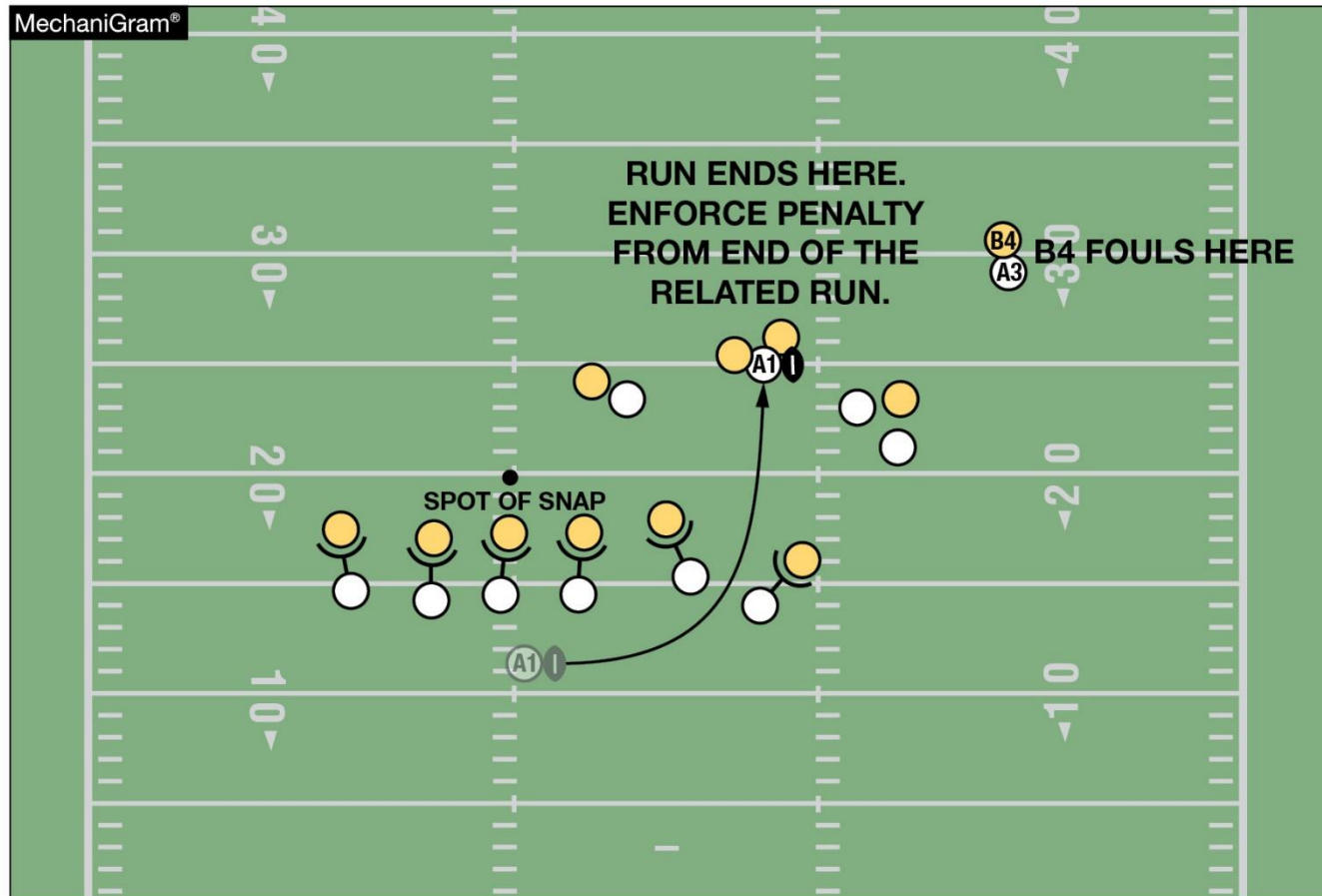
BASIC SPOTS RULE 10-4-6a



The basic spot is the end of the run or related run for a foul by B when the run or related run ends beyond the line of scrimmage.



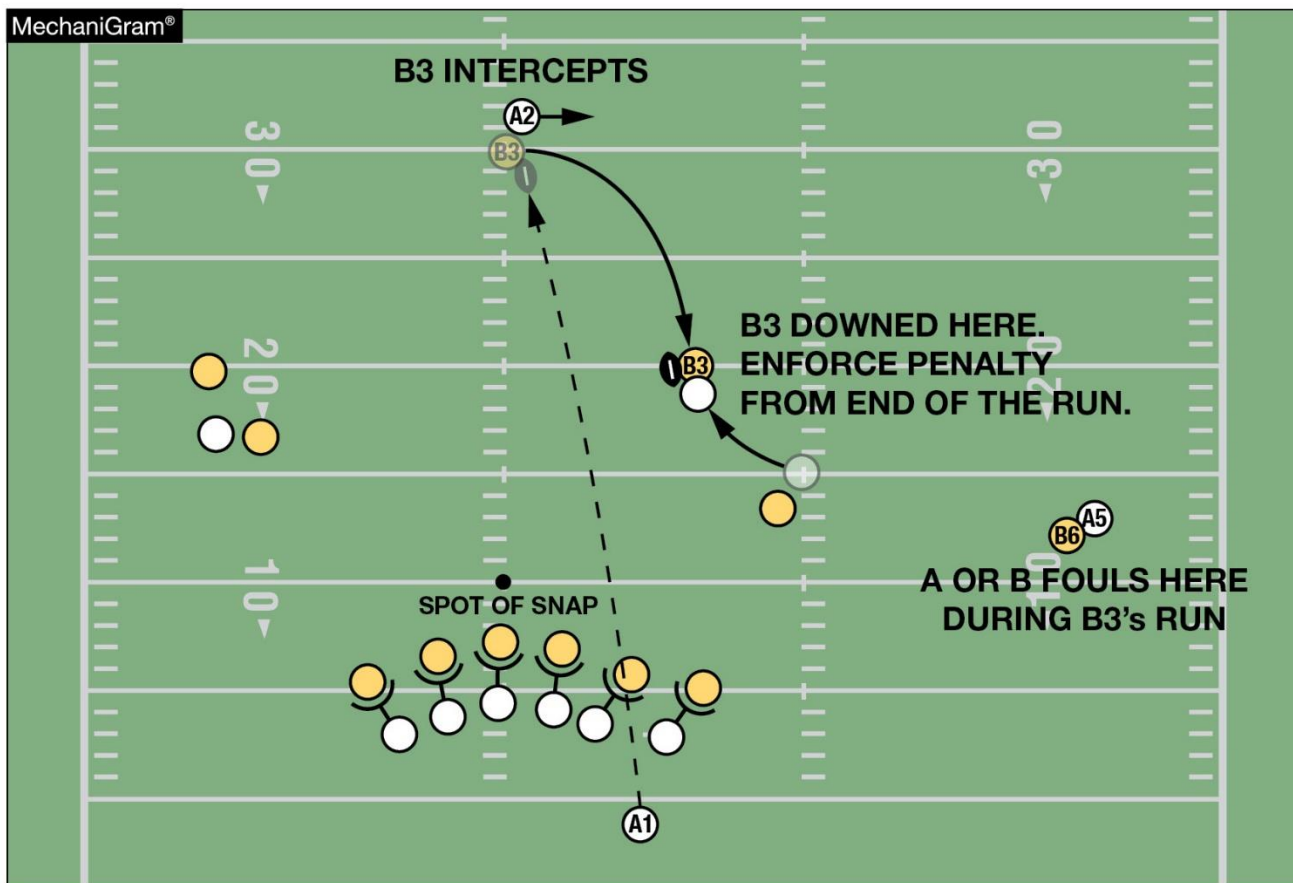
BASIC SPOTS RULE 10-4-6a



The basic spot is the end of the run or related run when the run or related run ends beyond the line of scrimmage and the foul occurs in advance of the end of the run or related run.



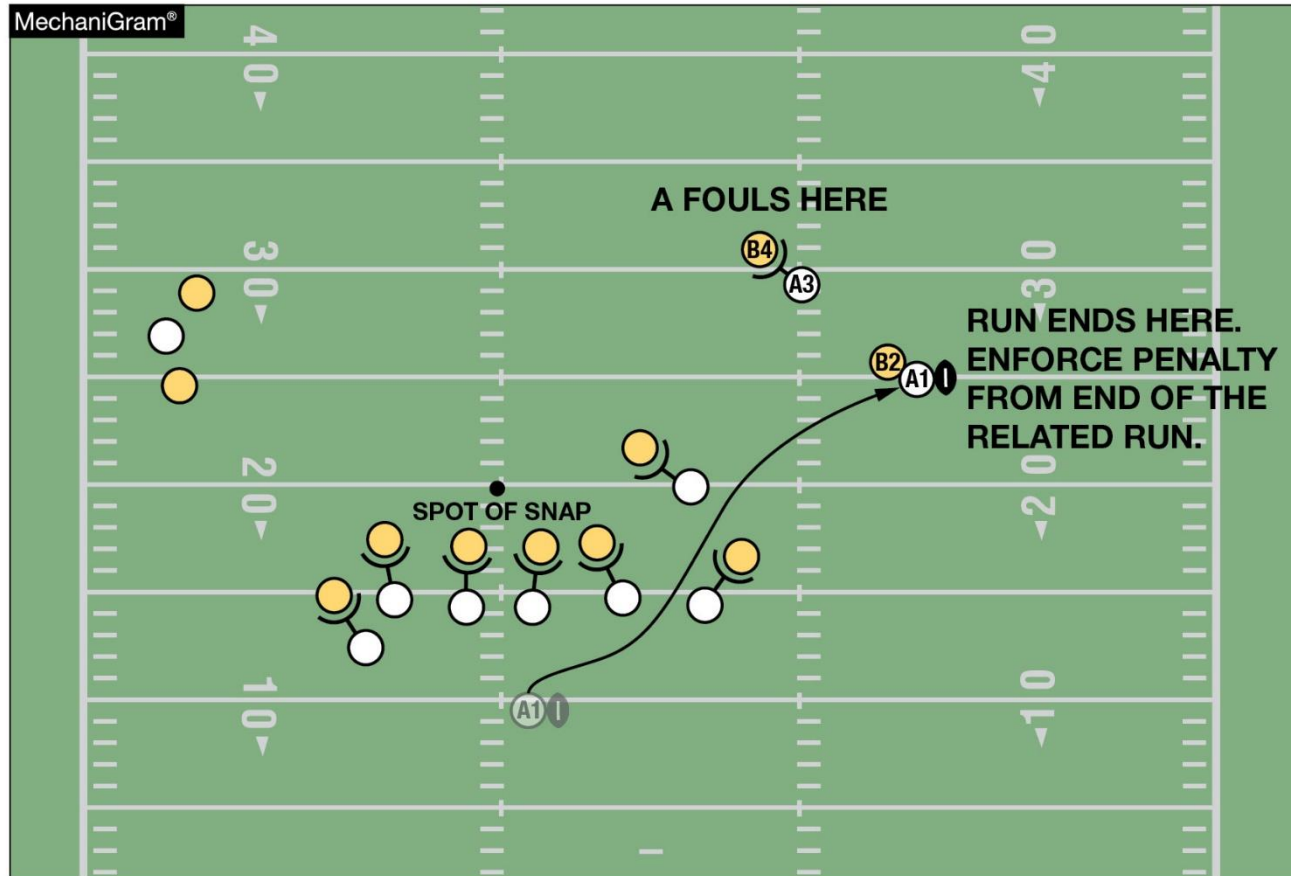
BASIC SPOTS RULE 10-4-6b



The basic spot is the end of the run or related run for a foul that occurs beyond the end of the run or related run following a change of possession.



BASIC SPOTS RULE 10-4-6c



The basic spot is the end of the run or related run for a foul by A that occurs beyond the line of scrimmage during a running play.

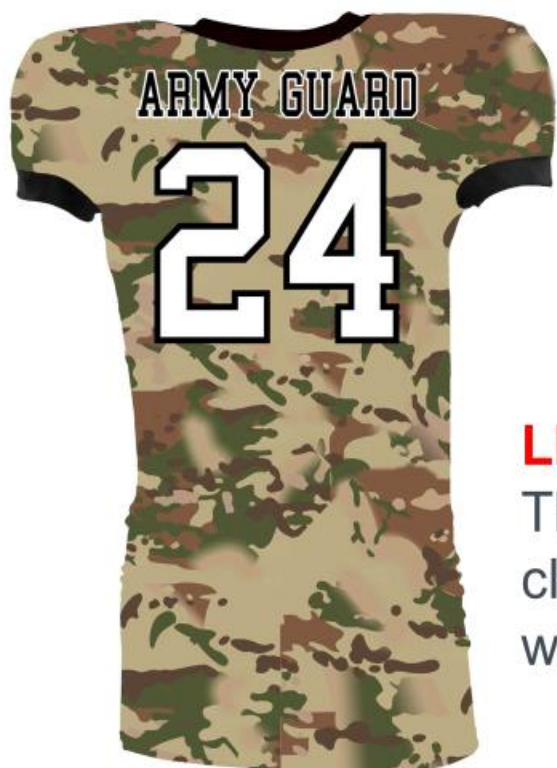

2024 - FOOTBALL JERSEY NUMBERS RULES 1-5-1c; 1-5-1c(5)



Effective with the 2024 season, the entire body of the number (the continuous horizontal bars and vertical strokes) shall be a single solid color that clearly contrasts with the body color of the jersey.

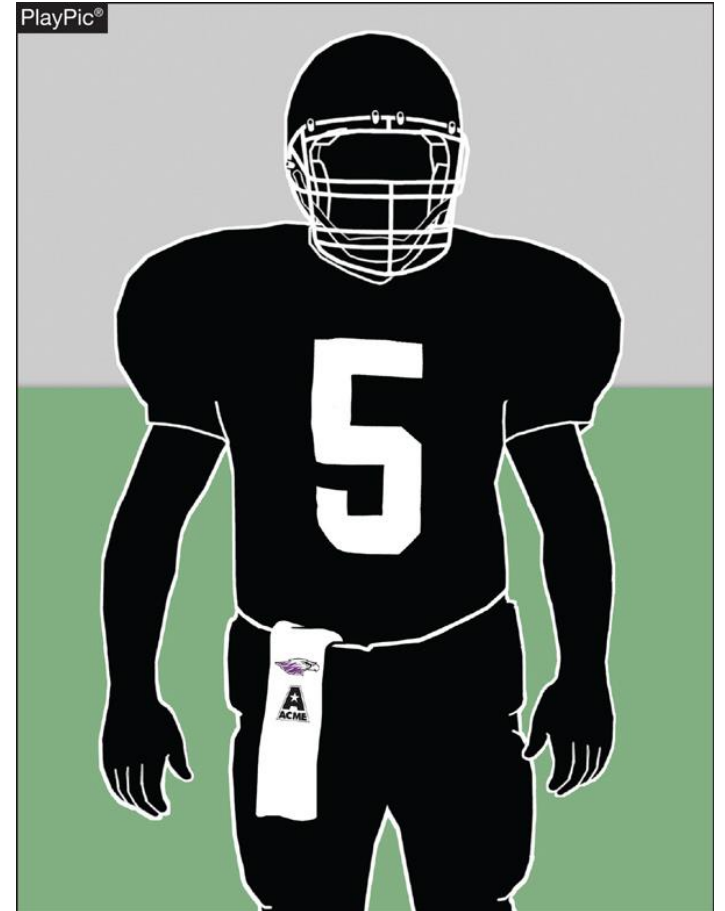


UNIFORM ADORNMENTS - TOWELS

RULE 1-5-3a(5)a 4, 5

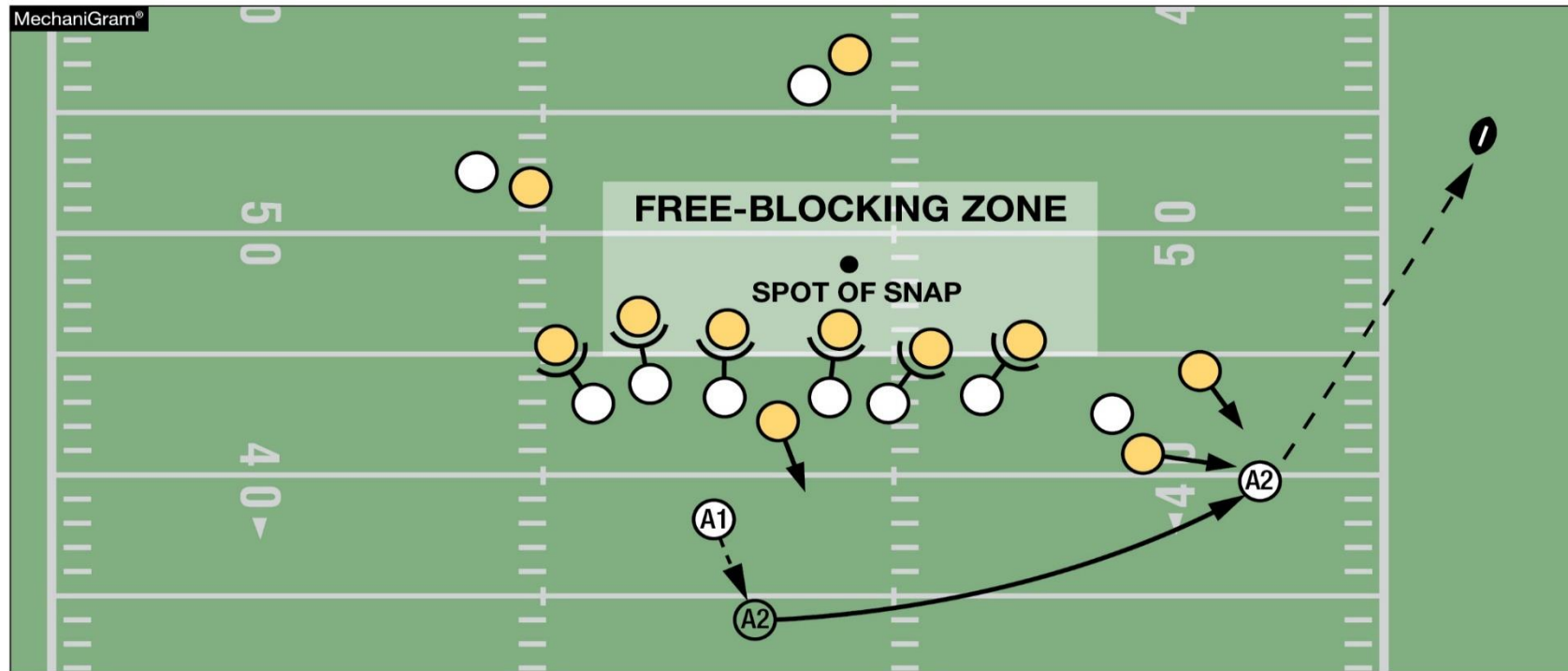
It is legal for a player to have one moisture-absorbing solid-colored towel that has no more than one visible manufacturer's logo/trademark reference that does not exceed 2¼ square inches and does not exceed 2¼ inches in any dimension; and has no more than one school logo/trademark reference that does not exceed 2¼ square inches and does not exceed 2¼ inches in any dimension.

Towels do not have to be the same solid color for each player.



INTENTIONAL GROUNDING EXCEPTION

This is a foul for intentional grounding since A2 is the second player to possess the ball. Only the player who possessed the ball after the snap ends may take advantage of the intentional grounding exception.

SPORTSMANSHIP AND ALTERCATION PREVENTION AND PROTOCOL



Coaches must teach, promote, model and set clear standards of behavior for themselves, players and fans. Game officials must fairly and consistently enforce NFHS rules in all aspects related to unsporting behavior by coaches and participants. Everyone involved must clearly understand that education-based athletics is an extension of the classroom and is about more than just winning and losing.

SPORTSMANSHIP AND ALTERCATION PREVENTION AND PROTOCOL



Fights that escalate beyond the initial incident tend to do so because others run toward the fight. Coaches are urged to instruct their team and even practice what to do in case an altercation occurs.

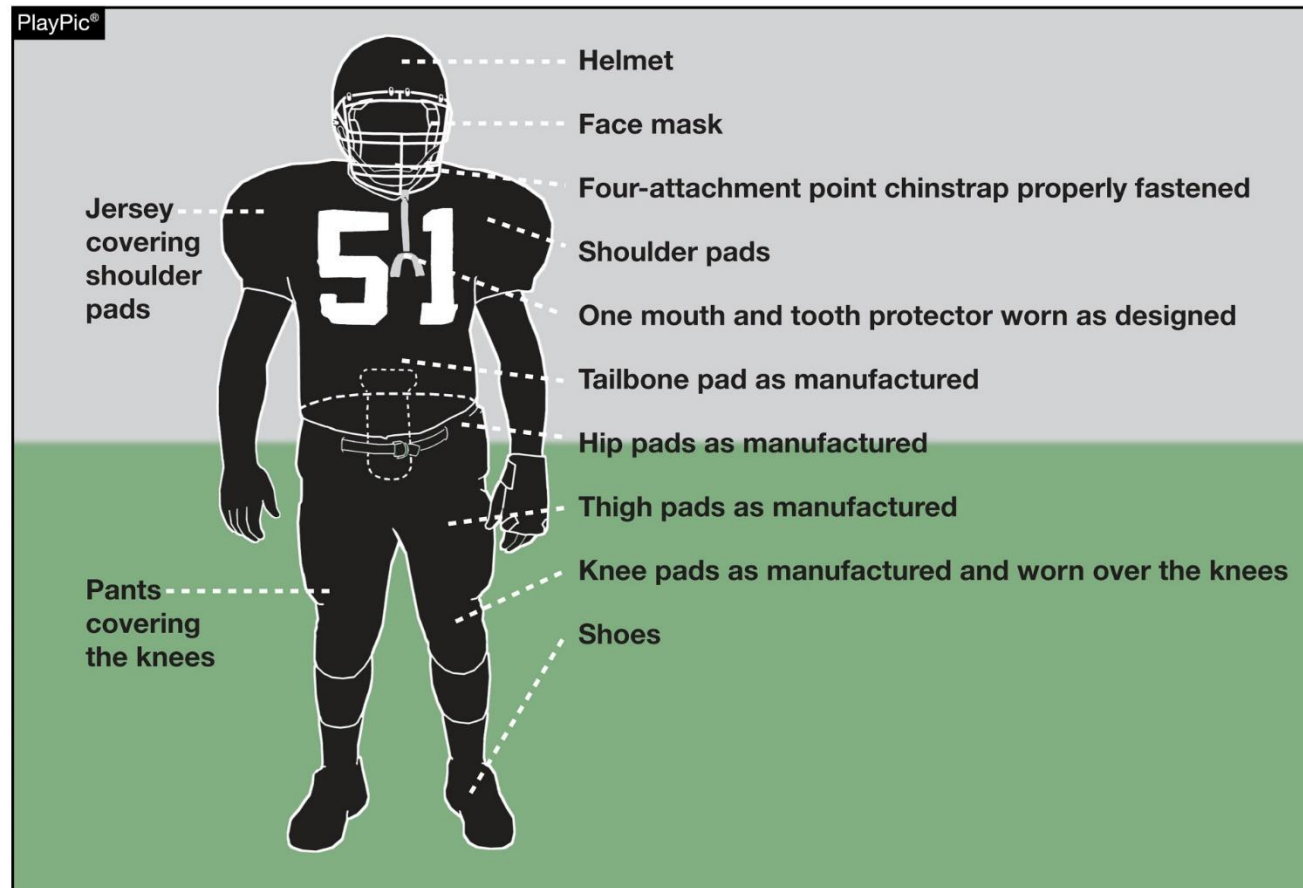


Postgame handshake line protocol should be followed by both teams. Among the points, administrators and security from both schools should be stationed on the field in close proximity to the handshake line. One team should be on the right and the other team should be on the left. Players from one team should not be allowed to walk down both sides of the line.



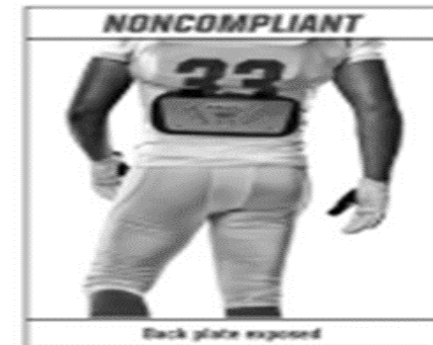
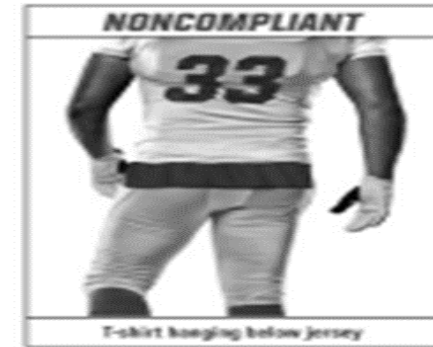
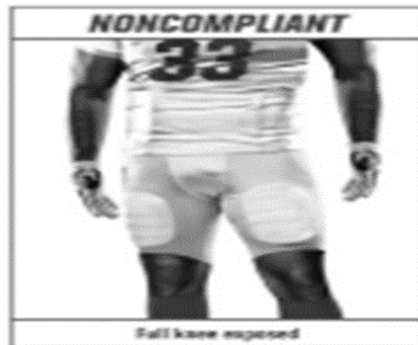
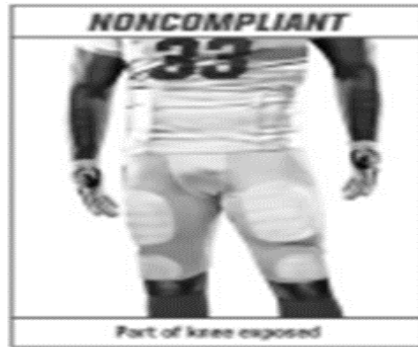
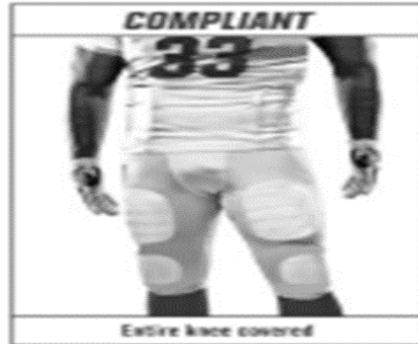

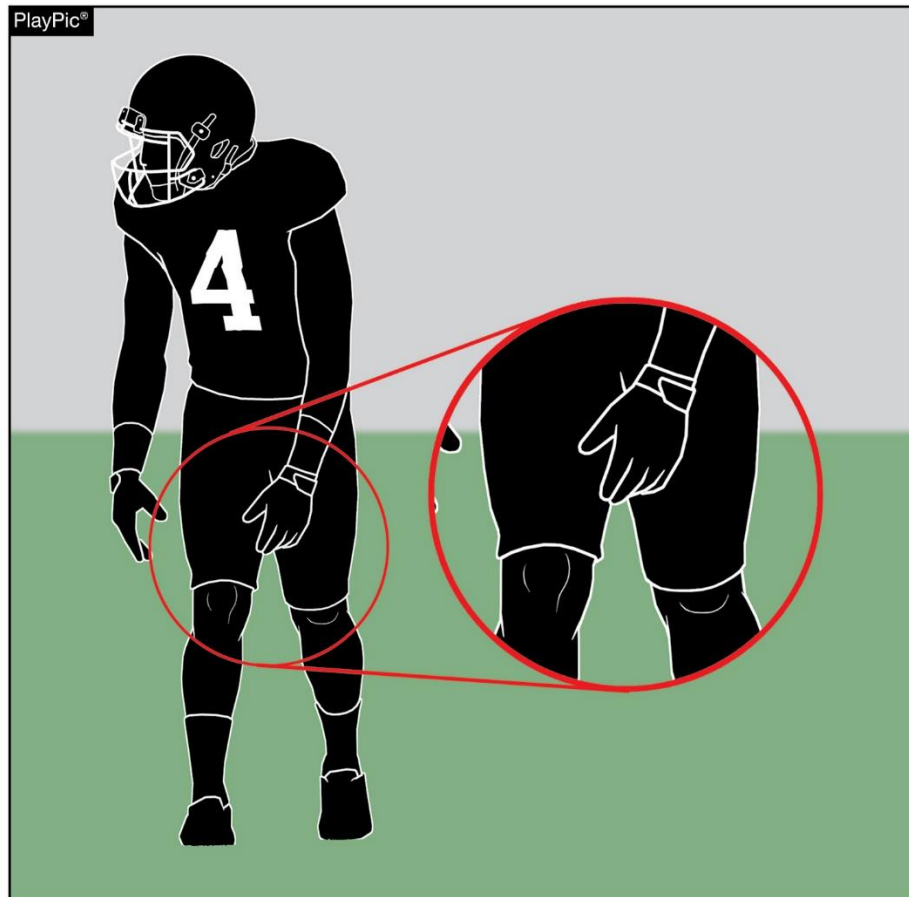


To support the safety of all participants, players must wear equipment and uniforms that are properly fitted and worn as intended by the manufacturer. Before starting each game, the head coach must verify that all players are properly and legally equipped.

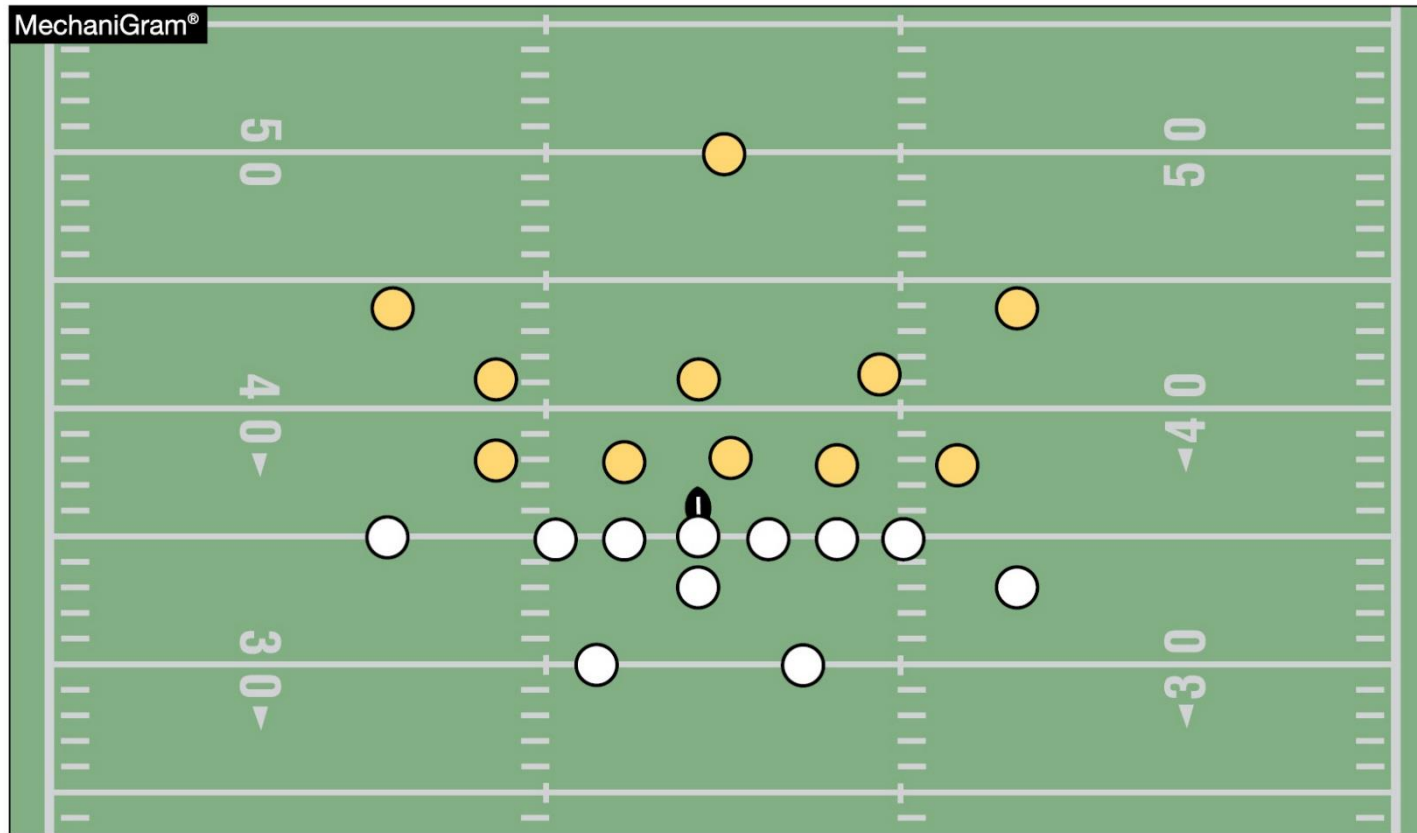


PLAYER EQUIPMENT AND ENFORCEMENT



Due to potential injury, it is essential that players only be allowed to participate if their pants and knee pads comply with the rules. Pants must completely cover the knees, and knee pads must be worn over the knee. Game officials should be watchful and proactive in addressing potential equipment, and more specifically, knee pad issues.

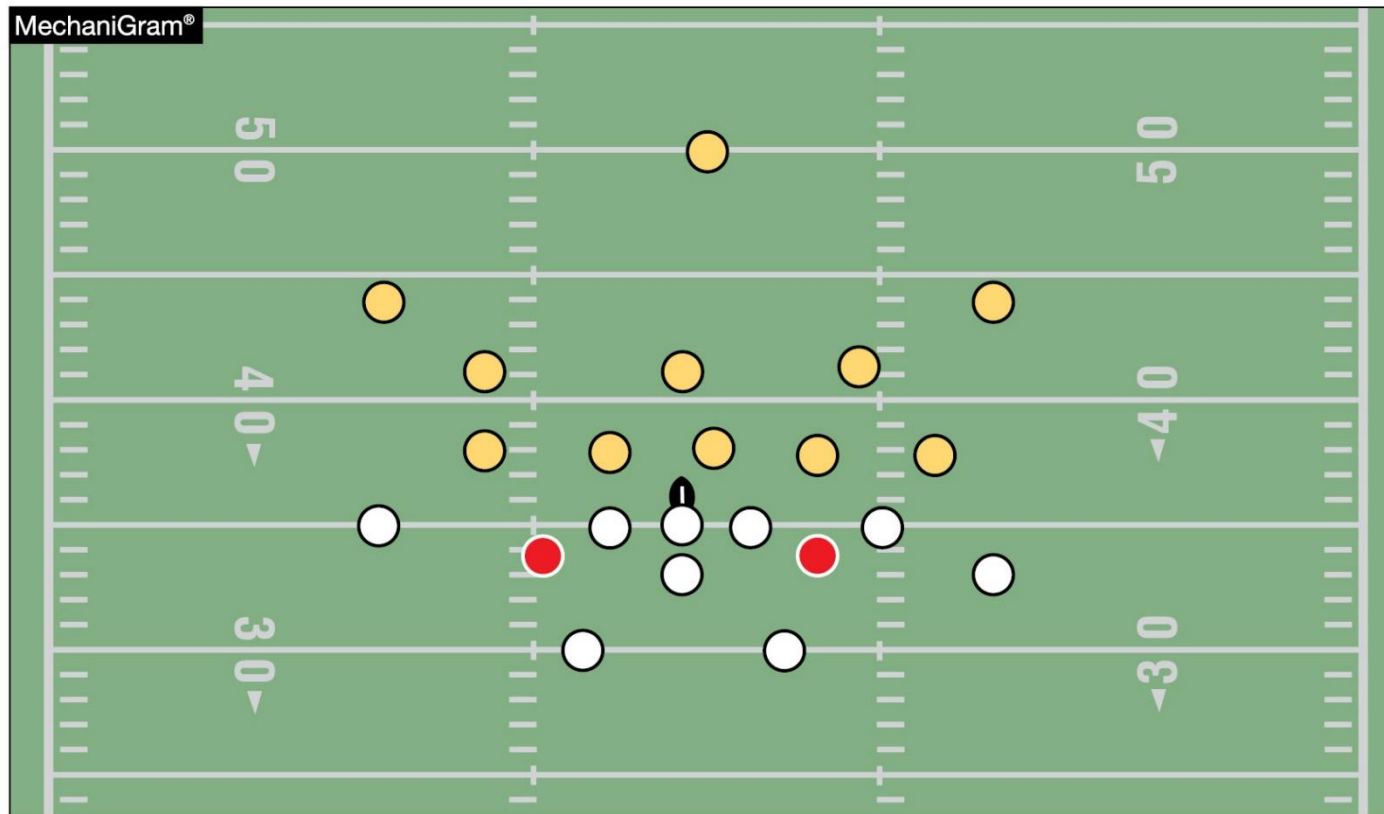
FORMATIONS



LEGAL

A legal formation has no more than four players in the backfield. A back is any A player who has no part of his body breaking the plane of an imaginary line drawn parallel to the line of scrimmage through the waist of the nearest teammate who is legally on the line, except for the player under the snapper, who is also considered a back.

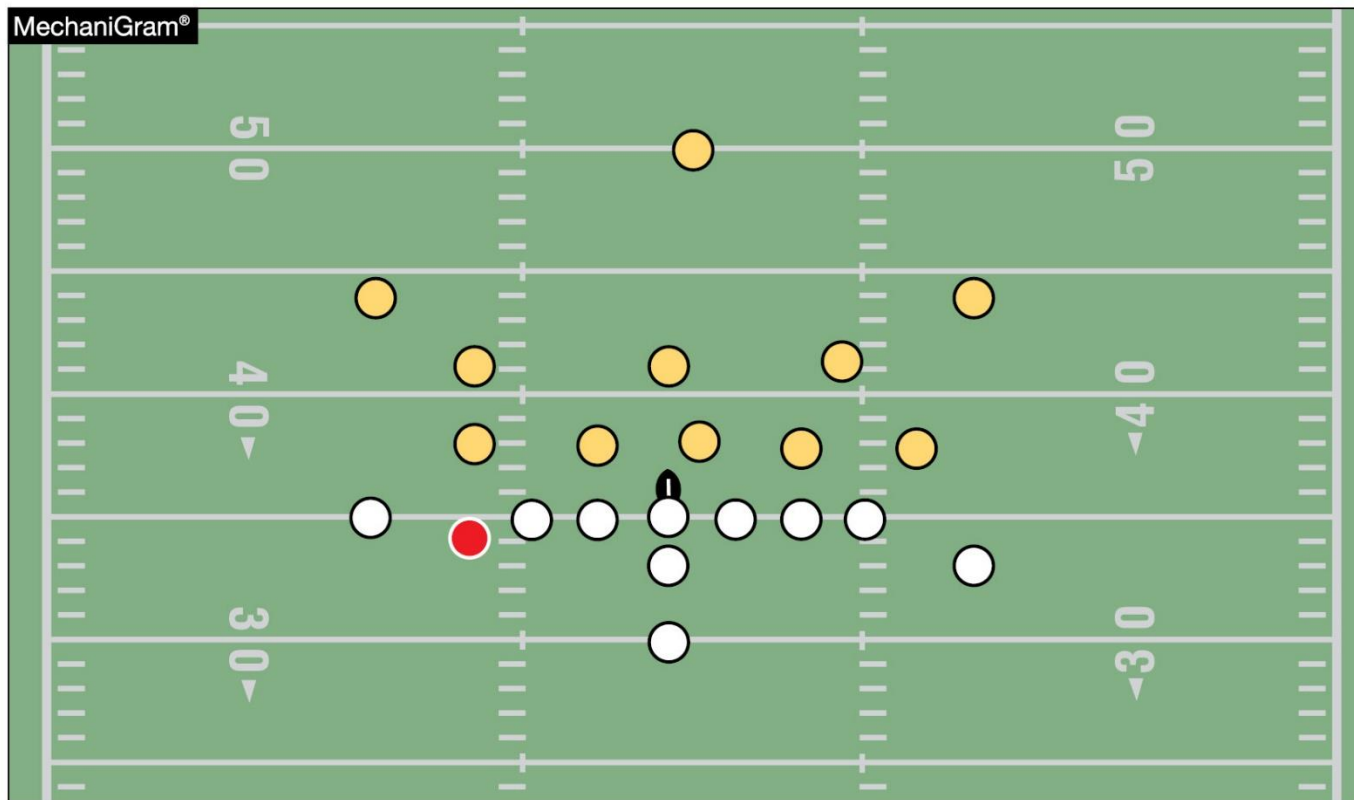
FORMATIONS



ILLEGAL - TACKLES OFF THE LINE

Linemen are legally on the line of scrimmage when they face their opponent's goal line and have head or foot breaking the imaginary plane through the waist of the snapper. It has become fairly common to see guards or tackles line up a yard or two off the ball to aid in pass blocking or pulling.

FORMATIONS



ILLEGAL - PLAYER NEITHER A LINEMAN NOR A BACK

If an offensive player lines up by intersecting the waistline of the tackle, but not the center, Team A has committed an illegal formation foul because all Team A players must be a lineman or back. Receivers who wish to line up as a back should have “daylight” between the rear end of the nearest lineman and their nearest body part.

CREW OF FOUR

SCRIMMAGE PLAY

Referee: While Team A is in the huddle, take a position approximately 10-15 yards from the line of scrimmage and 5 yards side of the huddle to be more visible to the clock operator. Once Team A is at the line, starting position is on the passing-arms side of the quarterback, approximately 10 to 12 yards deep and at least as wide as the tight end.

Umpire: Starting position is 5 to 10 yards behind Team B's line and between the defensive ends. The umpire must be able to see the ball from the time the snapper handles the ball until the time it is snapped.

Head linesman and line judge: Starting position is straddling the line of scrimmage on the sideline. Working on the sideline is strongly encouraged.

CREW OF FIVE

SCORING KICK

Referee: Starting position is 2 to 3 yards to rear and 3 to 5 yards to side of potential kicker, facing huddle.

Umpire: Starting position is 4 to 7 yards off line.

Wing officials: The wing official facing the referee remains on the line and on the sideline, while the opposite wing joins the back judge behind the upright. The MechanGram depicts a situation in which the line judge is deep and the head linesman remains on the line.

Back judge: Starting position is beyond the end line and behind the upright.

NOTE: On a field-goal attempt by free kick, the chains are set to establish the 10-yard neutral zone. Referee is behind the upright. Umpire is behind the upright and rules on crossbar. Both game officials determine whether kick is successful. All other game officials' mechanics are the same as for a kickoff.

CREW OF SEVEN

MOTION DOESN'T CHANGE STRENGTH

Strength is to the head linesman's side. Even if the back goes in motion to the line judge's side, strength is not considered to have changed. The side judge keys the widest receiver on the strong side. The back judge keys the flanker on the strong side. The head linesman keys the deepest back. The field judge keys the widest receiver on his side. The line judge keys on the back closest to the line.

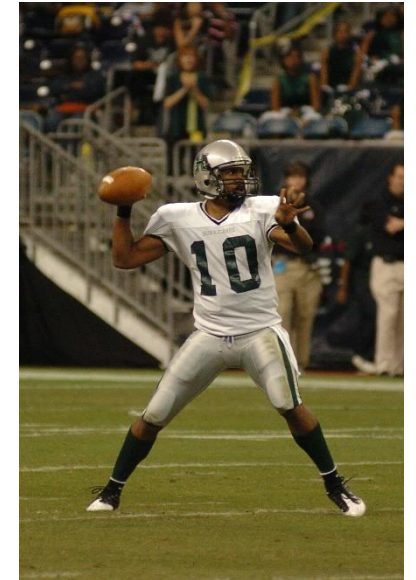

SUGGESTED GUIDELINES FOR MANAGEMENT OF CONCUSSION IN SPORTS

COMMON SIGNS AND SYMPTOMS OF CONCUSSION INCLUDE:

- Headache or "pressure" in head;
- Neck pain
- Dizziness
- Dazed or stunned or vacant appearance;
- Confusion about assignment or position;
- Forgetfulness;
- Uncertainty of game, score, or opponent;
- Clumsy movements;
- Slow response to questions;
- Mood, behavior or personality changes;
- Can't recall events prior to or after hit or fall;
- Nausea;
- Balance problems or dizziness;
- Double or blurry vision;
- Sensitivity to light or noise;
- Feeling sluggish, hazy, foggy or groggy;
- Concentration or memory problems;
- Emotions of "not feeling right" or "feeling down."

Activate the Emergency Medical System or Call 9-1-1 if, after a blow, or jolt to the head or body, an athlete has one or more of these danger signs:

- One pupil larger than the other;
- Drowsiness or inability to wake up;
- A headache that gets worse and does not go away;
- Slurred speech, weakness, numbness, or decreased coordination;
- Repeated vomiting or nausea;
- Convulsions or seizures (shaking or twitching);
- Unusual behavior, increased confusion, restlessness, or agitation;
- Loss of consciousness (passed out/knocked out). Even a brief loss of consciousness should be taken seriously. Consider activating EMS for prolonged loss of consciousness.

SUGGESTED CONCUSSION MANAGEMENT:

1. No athlete should return-to-sport (RTS) or practice on the same day of a concussion.
2. Any athlete suspected of having a concussion should be evaluated by an appropriate health-care professional as soon as possible.
3. Any athlete with a concussion should be medically cleared by an appropriate health-care professional prior to resuming participation in any practice or competition.
4. After medical clearance, RTS should follow a step-wise protocol with provisions for delayed RTS based upon return of any signs or symptoms at rest, while doing school work or with physical activity.

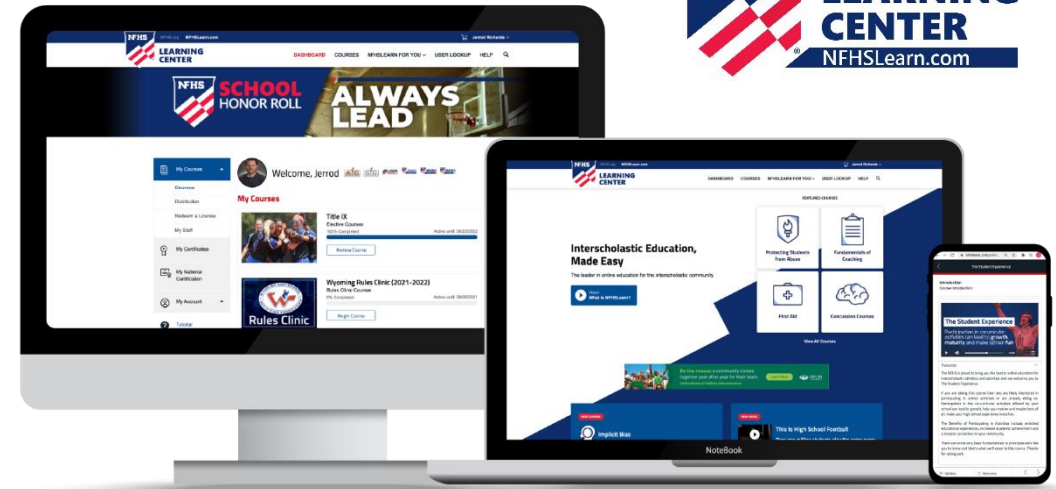

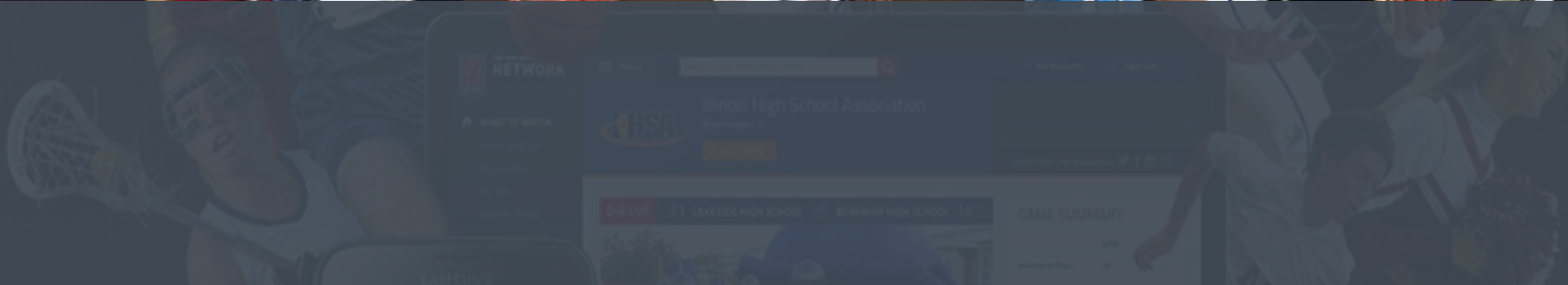
